

RINRI Californira, Corporate Membership Policy

RINRI Kenkyusho USA is a nonprofit organization registered in State of California and a subsidiary of RINRI Kenkyusho in Japan. RINRI Corporate Membership California, hereafter called "Organization", is a chapter of RINRI Kenkyusho USA. The Organization is often called RINRI Hojinkai.

The purpose of this policy is to establish the terms and conditions of membership in the RINRI Hojinkai, and to define the rights and obligations of RINRI Hojinkai and its member, hereafter called "Member". By becoming a member of RINRI Hojinkai, the Member agrees to abide by the guidelines and rules set forth in this policy, as well as any additional guidelines and rules that may be established by the Organization from time to time.

PURPOSE

Based on RINRI, often called pure ethics, its correctness is immediately proven by daily practice of RINRI. Our purpose is to achieve self-development and to expand the network of people who pursue for improved management. Realize sound prosperity in accordance with the spirit of co-existence, and to contribute to the development of local communities and the creation of a harmonious world.

- 1. Provide a place for RINRI learning and practice to train leaders with better lifestyle and enrich humanity.
- 2. Bring up people who love their families deeply, respect their ancestors, and build a peaceful and loving home.
- 3. Promote the creation of a successful workplace through the practice of being cheerful, loving, and working with joy.
- 4. Expand the circle of members who aim for the management with love, respect, and gratitude, and contribute to the development of local communities through various activities.
- 5. Respect and love nature, deepen our awareness of our "Earth", and contribute to the conservation and beautification of our environment.

MEMBERSHIP FEES

- 1. \$50/month
- 2. Automatic debit from member's credit/debit card at the beginning of each month.
- 3. No refunds on the membership fees that you have already paid.

- 5. No enrollment fee is required.

- 7. Consultation available on employee training.
- 8. Attend various seminars at Fuji Training Center in Japan at member discount price.

MEMBERSHIP CANCELLATION

Membership will be cancelled in the following cases:

- 2. When a participating corporation is dissolved.
- 3. Expulsions due to a long-term delinquency of the membership fees, an act to destroy the honor of Organization, or an act that violates our purposes.
